The committee provides advice on tourism issues in Kakadu to Park Management and the Kakadu Board of Management. The committee is chaired by the tourism industry nominee on the Board of Management and reports directly to the Board. Matters are brought to the committee either by the Kakadu Board of Management or by members on behalf of the groups they represent.

THE ROLE OF THE COMMITTEE

The committee was established by the Kakadu National Park Board of Management (KBoM). The committee is chaired by a Board member and reports directly to the Board. Some key aspects of the KTCC's role are:

- Provide Park Management and the KBoM with advice and industry expertise on future planning and development relating to tourism (both commercial and private) in the park
- Build understanding within the tourism industry of traditional owners' interests and park management objectives as they relate to tourism in the Park
- Establish and maintain a sound working relationship between Traditional Owners, Kakadu National Park and tourism stakeholders
- Advocate the unique environmental, cultural heritage and recreational values of the Park to the broader tourism industry
- Provide input into the continued relevance of the Kakadu Knowledge for Tour Guides program.
